Sir/Madam,

In continuation of this office letter no. 2979-3082/colleges dated 29.05.2025, it is informed that worthy Vice-Chancellor has approved the recommendations of committee in an anticipation of syndicate, to formulate the requisite framework and modalities for initiating the Ph.D. programme and setting up the Research Centre in the colleges affiliated with the University, are given as under:-

a) To establish a research center for offering PhD programmes, the College must have:

i) permanent affiliation with Guru Nanak Dev University (GNDU).

ii) a regular Principal and possess 2f and 12b status from the University Grants Commission (UGC).

iii) valid NAAC accreditation with at least an 'A' grade.

iv) offer four-year undergraduate and postgraduate programmes in the relevant subject, supported by the necessary infrastructure, administrative facilities, and research resources as specified by higher education institutes.

- v) Post-graduate departments of colleges, research laboratories of Government of India/State Government with at least two Ph.D. qualified teachers/scientists/other academic staff in the department concerned along with required infrastructure, supporting administrative and research promotion facilities as specified in the provision stated as given below in **paragraph** (e) shall be considered eligible to offer Ph.D. programmes. Colleges should additionally have the necessary recognition by the institution under which they operate to offer Ph.D. Programme.
- b) All permanent Professor/Associate Professor/Assistant Professor/ Principal working in affiliated <u>Post-graduate Colleges</u> of this University, holding Ph.D. degree alongwith five research publications and at least five years postgraduate teaching experiencemay beconsidered as a Research Supervisor.

In case of interdisciplinary/multidisciplinary research work, a Co-supervisor within the same department or other departments of the University shall be appointed with the approval of the competent authority.

Allocation of such Supervisor/co-supervisor will be recommended by the Board of Control of the concerned department of this University, who

will be eligible for admission after follow the admission process of the University provided that the University has approved the college as a research centre in the subject concerned.

c) Pre-Ph.D. course work of research scholars will be conducted in the University along with other candidates admitted in the main campus and the scholars will have to present their proposals & research before the Research Degree Committee (RDC).

The recommendations of RDC shall be approved by the Research Degree Board (RDB).

- d) College having approved research centre will provide laboratory, library support and all other facilities to conduct meaningful research.
- e) Colleges with adequate facilities for research as mentioned below alone shall offer Ph.D. programmes:
 - Research centers may be established in colleges for subjects related to all existing faculties.
- f) Earmarked library resources including latest books, Indian and International journals, e-journals, extended working hours for all disciplines, adequate space for research scholars in the department/library for reading, writing and storing study and research materials.
- g) Colleges may also have an access to the required facilities of the neighbouring Institutions/ colleges, or of those Institutions/ Colleges/ R&D laboratories / organizations which have the required facilities.
- h) An eligible Professor may register upto four candidates, Associate Professor can register upto three candidates, and an Assistant professor upto two candidates respectively.
- i) The Vice Chancellor has to constitute a committee to create a Research Centre and that committee will visit the colleges to look at the facilities as prescribed in the guidelines by the University and give its recommendations
- j) Research Centre established at colleges will be re-assessed/re-evaluated after a period of every five years by a committee appointed by the Vice Chancellor.
- k) The Supervisor must be familiar with and adhere to thePh.D. Ordinances of University, regarding supervision, examination and thesis submission requirements.
